WHAT DOES THE PADGETT AGENCY, INC DO WITH YOUR PERSONAL INFORMATION?

Why?

Insurance companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and date of birth
- Assets and Income
- Credit history

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All insurance companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons insurance companies can share their customers' personal information; the reasons The Padgett Agency, Inc. chooses to share; and whether you can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be insurance and noninsurance companies.

Nonaffiliates	Companies not related by common ownership or control. They can be insurance and noninsurance companies.	
	The Padgett Agency, Inc. does not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated insurance companies that together market noninsurance products or services to you.	
	■ The Padgett Agency, Inc. does not jointly market.
